

## **2018 Official Rules for the Winner Area Chamber of Commerce Holiday Promotion Drawing**

**Entry:** Collect all required stamps on passport, and turn in to the Winner Area Chamber of Commerce. Any completed passport between November 19, 2018 and December 20, 2018 (the "Promotional Period"), will be entered into the sweepstakes once with a maximum of three (3) passports per transaction.

Winners will be notified by Email or telephone on or about December 28, 2018, and may be required to sign an affidavit of eligibility/liability release, a publicity release where legal and federal and state tax releases; and return these documents, properly executed, at the time and in the manner required by Winner Area Chamber of Commerce. If a winner cannot be contacted by email or telephone after three (3) attempts made during a reasonable amount of time or a prize is returned as undeliverable, another winner will be drawn for that specific prize. Awarded prizes will be delivered via Winner cash and will be available to be picked up at the Winner Area Chamber of Commerce. Odds of winning depend upon the number of eligible entries received.

**Prizes:** On December 21 the first two (2) drawn passport winners will receive five hundred (500) in Winner Cash. On December 14, the first two (2) drawn passport winners will receive three hundred (300) in Winner Cash. On December 7 the first two (2) drawn passport winners will receive two hundred (200) in Winner Cash. On November 30 the first five (5) drawn passport winners will receive one hundred (100) in Winner Cash. If a prize or any portion thereof cannot be awarded for any reason, Winner Area Chamber of Commerce reserves the right to substitute prize with another prize of equal or greater value, or to pay the cash equivalent thereof as Winner Area Chamber of Commerce's sole discretion.
